Overview

JUDGING GUIDELINES

Following are the categories and notes relating to how they are scored:

1. Costume: How appropriate is the costume to plankwalking. While period attire is appreciated, contestants are encouraged to use their imagination to come up with an ensemble that impresses the judges and perhaps persuades them to be lenient in their scoring in this area.
2. Style: Points are awarded for how well the individual conducts themselves on their way to their seeming “watery grave.” Criteria covers plank approach, bravado, arrogance, guile, bribery, form on the plank and poise before the plunge.
3. Plea: Extra points for a marked amount of theater here. Groveling, cries for mercy, pleas of innocence, invocations, curses – all are eligible for Plea Points.
4. Splash: Finally, the judges want to hear a resounding splash upon entering the water. Sissy splashes are discouraged as are dives warranting an Olympic Medal. Maximum points for belly and butt flops.

Judges will score during the event at each juncture using score cards. The judges shall then enter their score on the contestant's sheet. All scores shall be added up. The most a contestant could conceivably get in the contest is 120 points, (4 categories/three judges) a perfect score. The most anyone can get in a single category above is 30 points.

Each contestant shall be judged in a similar fashion. At the end of the contest, all scores shall be added up. Judges are encouraged to write comments that will be read at the awards ceremony

The winner with the highest score is awarded the National Walk the Plank Championship.

There are three places in the contest, First, Second and Third. In the case of a tie, Style will be the determinant and the contestant with the highest Style score shall be awarded the place.

The tally containing the top three winners and the other finishers in order shall be turned over to the head judge for presentation and awarding of the prizes.
